SNOWTAM ITEM T GUIDANCE

1 Additional guidance for SNOWTAM Sponsors regarding Item T PLAIN LANGUAGE REMARKS.

The current EAD system used for processing of SNOWTAMs contains software to ensure that the correct format and elements are used, this includes the application of various validation rules

As a consequence, to prevent errors or warnings from being generated due to ITEM T and also ITEM S elements, the below guidance shall be considered. This is in accordance with the EUROCONTROL - EAD Service Operational User Handbook - Data Provider, Appendix J (*EAD/DOC-GEKB38*):

- Item T shall start with RMK/.
- Item T shall use ITA-2 character set.
- Item T & S Items should not be separated using 'full stop', multiple Item T entries should be separated using an oblique in the format [space] / [space]. A single 'full stop' shall only be at the end of Item T.
- If Item S elements exist, they shall be placed also after the RMK/.

In Item T, the following keywords shouldn't be used as they will generate errors and may result in SNOWTAM being rejected. Suggested ICAO 8400 alternatives have been provided if required.
