

EACCC COVID-19 Harmonised NOTAM

Format

The European Crisis Coordination Cell together with all key Stakeholders strongly recommends the use of the following NOTAM Format templates for COVID-19 publications.

During the past days, the EUROCONTROL Network Manager (NM) has received a large number of COVID-19 related NOTAMs which showed a large variation in format and content.

In order to facilitate the readability and to reduce potential interpretation differences, NM recommends in coordination with key stakeholders the following harmonised approach.

NOTAMs received to date can be divided into three main categories:

- 1. NOTAMs with restrictions (either flight restrictions, passenger restrictions or both)
- 2. NOTAMS with requirements for crew or passengers (health declarations, Passenger Locator Form, quarantine etc.)
- 3. Informational NOTAMs

The fields Q), A), B), and C) should be filled as usual. For the E) field it is essential that the **COVID-19** reference is used, preferably at the beginning together with a subject keyword.

For NOTAMs on flight restrictions the following format should be used:

Note: Examples of exception criteria are nationals, residents, self-quarantine etc.

For NOTAMs on crews/passengers requirements the following format should be used:

ENR ATS IS NORMAL AND AIR OPERATORS ARE ABLE TO FILE [aerodrome names] AS ALTERNATE AERODROMES.
