NOTIFICATION OF ERROR IN VFR CHARTS

1 Introduction

1.1 The following listed VFR Charts all state contact 119.875 (At or Below FL55). However, some airspace below FL55 is Class E. This may have lead GA pilots, flying VFR, to request a FIS in Class E Airspace from FIS SCOTTISH INFO on 119.875, when they should be contacting the appropriate controlling authority.

TRAFFIC WITHIN OR BENEATH THE SCOTTISH TMA, REQUIRING A FIS BELOW 5500', SHOULD CONTACT SCOTTISH INFORMATION ON 119.875. HOWEVER, PILOTS ARE ADVISED WHEN FLYING IN THE CLOSE VICINITY OF THE AERODROME CTA/CTR TO MAKE CONTACT ON THE CONTROLLING FREQUENCY FOR THAT AERODROME TO REQUEST AN AIR TRAFFIC SERVICE.

TRAFFIC BENEATH THE SCOTTISH TMA, OUTSIDE OF CAS, REQUIRING A FIS, SHOULD CONTACT SCOTTISH INFORMATION ON 119.875. VFR TRAFFIC WITHIN CLASS E, REQUIRING A FIS, SHOULD CONTACT THE APPROPRIATE CONTROLLING AUTHORITY FREQUENCY. PILOTS ARE ADVISED WHEN FLYING IN THE CLOSE VICINITY OF THE AERODROME CTR/CTA TO MAKE CONTACT ON THE CONTROLLING FREQUENCY FOR THAT AERODROM TO REQUEST AN AIR TRAFFIC SERVICE.
