RESTRICTION OF FLYING REGULATIONS: ISLE OF MAN TT RACES, 27 MAY – 09 JUNE 2024

- 1** The Isle of Man TT Races will be held **from 27 May to 09 June 2024**. The Isle of Man Civil Aviation Administration has deemed it necessary to introduce the Civil Aviation (Restriction of Flying) (Isle of Man TT Races) Regulations 2024 (SD No. 2024/0082) in order to restrict flying in the vicinity of the event.
- 2** The Restricted Airspace (Temporary) includes all of the airspace from the surface up to an altitude of 3000 FT AMSL in the area bounded by straight lines joining successively the following points:
 - a) 541952N 0042233W;
 - b) 541904N 0042140W;
 - c) 541800N 0042147W;
 - d) 541610N 0042530W;
 - e) 541420N 0042650W;
 - f) 541000N 0042708W;
 - g) 540825N 0042958W;
 - h) 541055N 0043600W;
 - i) 541145N 0043840W;
 - j) 541311N 0043906W;
 - k) 541535N 0043609W;
 - l) 541659N 0043624W;
 - m) 541845N 0043436W;
 - n) 541955N 0042838W; and
 - o) 541952N 0042233W.
- 3** The Restricted Airspace (Temporary) will be activated by NOTAM.
- 4** The Restricted Airspace (Temporary) applies to all aircraft, including small unmanned aircraft of any MTOM, except those flying in accordance with a permission issued by the Isle of Man Civil Aviation Administration or an authorised person.

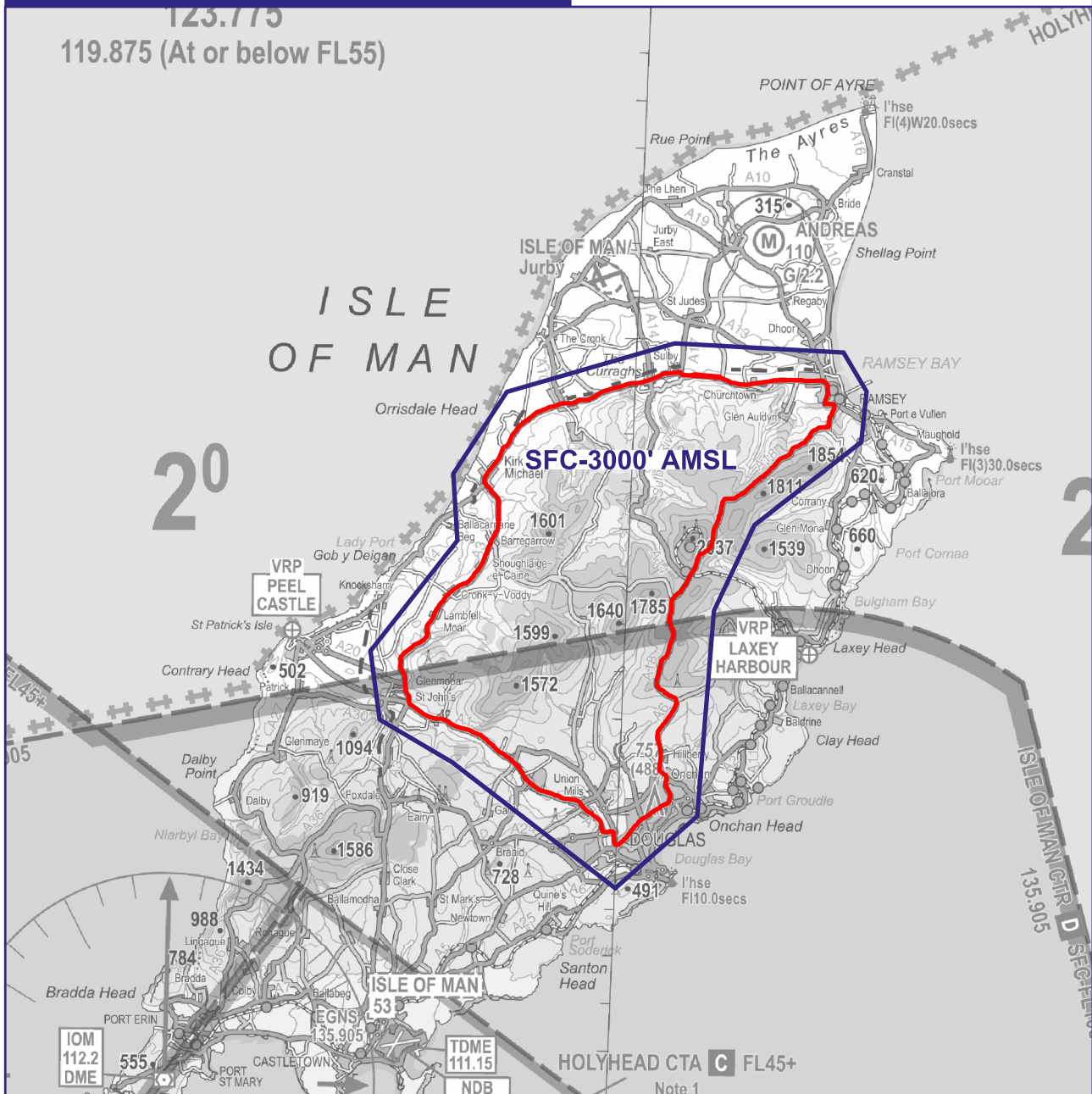
