## RESTRICTION OF FLYING REGULATIONS: KING'S BIRTHDAY FLYPAST, 15 JUNE 2024

**1** A large formation of military aircraft will form His Majesty the King's Birthday Flypast on **15 June 2024**. The flypast will impose restrictions in the vicinity of the North Sea, East Anglia, Essex and London, to overfly Buckingham Palace. The dispersal will occur to the West and North West of London over Berkshire, Buckinghamshire and Oxfordshire. Due to the large number of aircraft involved, the Secretary of State for Transport has decided that it is necessary to introduce Restriction of Flying Regulations under Article 239 of the Air Navigation order 2016.

**2** The charts in this document relate to the areas defined in the associated text; all areas will be subject to NOTAM action; these are to be read in conjunction with this document. Pilots are strongly encouraged to employ the use of moving map technology and/or an air traffic service to mitigate the risk of inadvertent airspace infringements.

The times mentioned in this Notice are Universal Co-ordinated Time (UTC), which is one hour behind British Summer Time (BST).

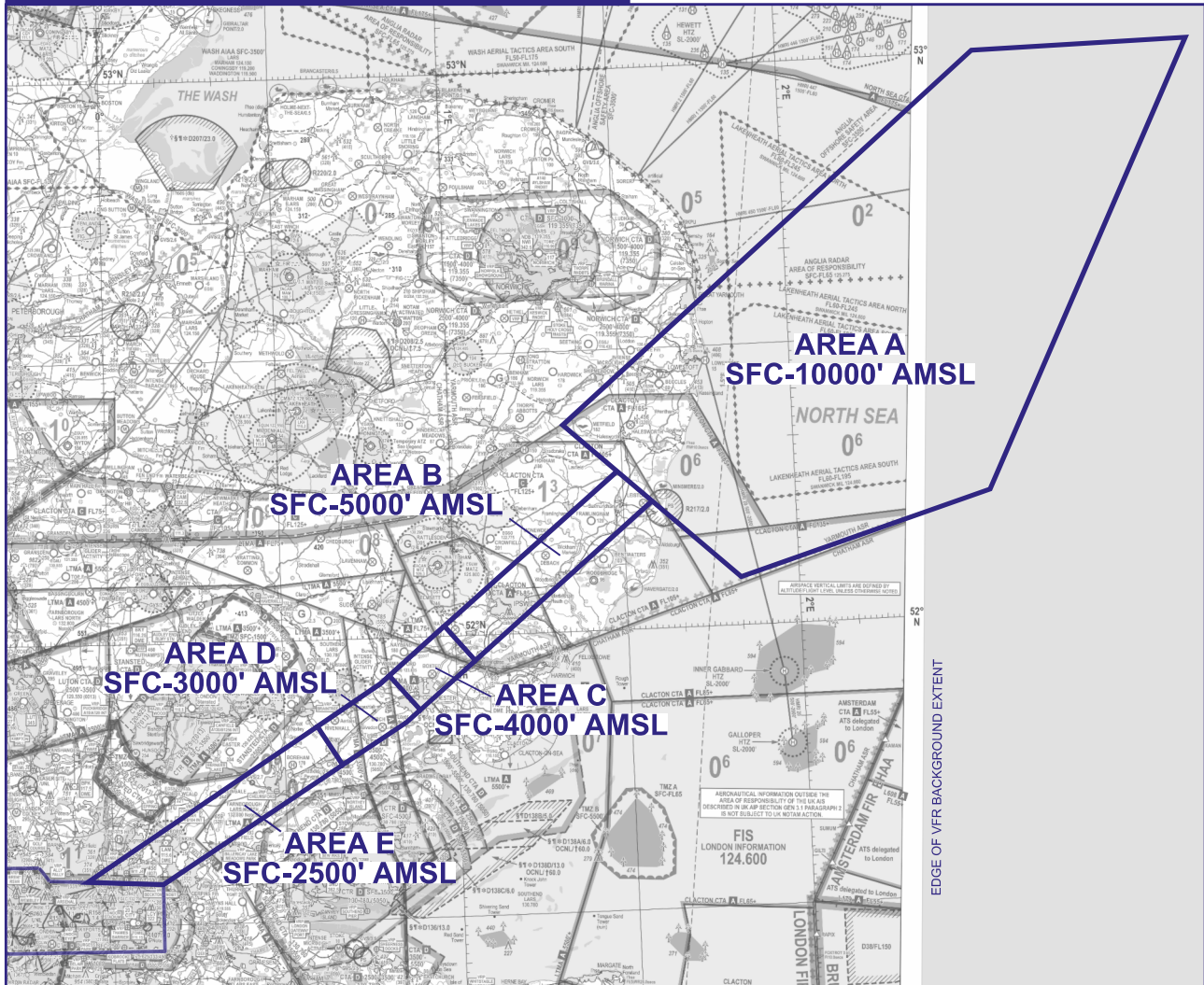

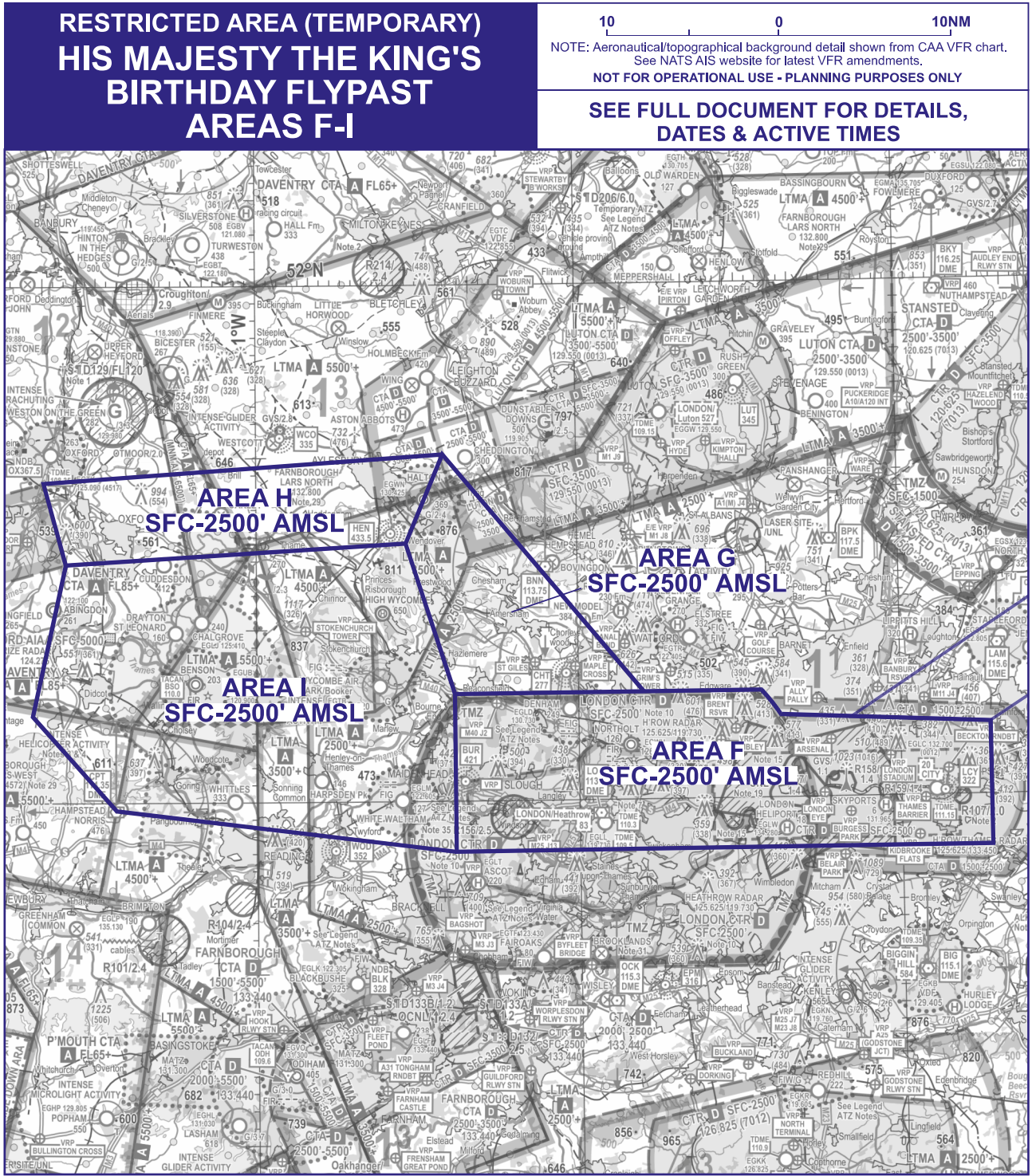

- 15** These Restricted Areas (Temporary) directly affect a number of Aerodrome Traffic Zones and also aerodromes and flying sites that do not have Aerodrome Traffic Zones. Aerodrome Operators and ATS Units affected by the Restricted Areas (Temporary) are requested to bring this Circular to the attention of their resident and local operators.
- 16** In relation to this document, the term 'aircraft' includes any small balloon, any kite, any unmanned aircraft and any parachute including a parascending parachute or paramotor.
